

Crime in Schools, 2020-2024

Executive Summary

The FBI's Uniform Crime Reporting (UCR) Program collects crime data from agencies across the country through the National Incident-Based Reporting System (NIBRS). From 2020 to 2024, agencies reported 1,299,063 criminal incidents occurring at school locations via NIBRS. There were 1,504,310 offenses; 1,539,149 victims; and 1,250,077 known offenders associated with those incidents. This subset of NIBRS data shows the following information was reported:

- Assaults were the most reported offenses in the Crimes Against Persons category.
- Larceny/thefts were the most reported crimes in the Crimes Against Property category.
- *Drug/narcotic* offenses were the most reported crimes in the Crimes Against Society category.
- When a weapon was involved in a crime, it was most often *personal weapons* (hands, fists, feet, etc.).
- The most common month for incidents to occur was September.
- Most victims who were 18 years of age or younger were between 13 and 15 years old.
- Most victims were *female*.
- The most reported race of victims was *White*; the most reported ethnicity was *Not Hispanic or Latino*.
- Most victims were *residents* of the jurisdiction where the incident occurred.
- Many of the victims were not hurt or suffered only a *minor injury* and were *acquainted with the offender*.
- When looking at the known offenders, the age group reported most frequently was 13-15; sex, *male*; race, *White*; and ethnicity, *Not Hispanic or Latino*.

¹ Prior to 2010, school/college was the only data value available to agencies under the data element location type, when an incident reportedly occurred at an educational institution. School-elementary/secondary and school-college/university were added as data values in 2010 to better distinguish between the demographics of the students enrolled.

Introduction

It is vital to study crime in schools and colleges, along with learning the characteristics of the victims and offenders, in order for law enforcement agencies, policy makers, school administrators, and the public to properly combat and reduce the amount of crime occurring at these institutions. This study examines the characteristics of victims and offenders involved with incidents at schools, which were reported to the FBI's UCR Program via NIBRS by participating law enforcement agencies. Through NIBRS, agencies can report specific details about criminal incidents in schools, including victim and offender information and the type(s) of weapons used. This study uses NIBRS data from 2020 to 2024 related to crime that occurred in schools. Details regarding data collected in NIBRS can be found in Appendix A.

Number of Agencies and Population Coverage by Year

Table 1 shows the number of agencies reporting crime in schools via NIBRS and the population covered by those agencies.

Incidents, Offenses, Victims, and Known Offenders by Year

Table 2 shows the number of *incidents*, *offenses*, *victims*, and *known offenders* associated with crime in school locations over the 5-year period. The increase in reported *incidents* and the related *offenses*, *victims*, and *known offenders* may be a result of the increase in law enforcement agency participation in NIBRS. The offense rate per 100,000 inhabitants for those agencies reporting crime in schools can be found in Table 4-A in Appendix A.

² The number of offenses for Crimes Against Persons is determined by the number of victims, while the number of offenses for Crimes Against Property and Society is based on each distinct operation. Aggravated assault is a Crime Against Persons; therefore, 1 offense is tallied for each victim. Robbery, a Crime Against Property, only counts 1 offense for each distinct operation, regardless of the number of victims.

⁴ The term *known offender* does not imply that the identity of the suspect is known, but only that an attribute of the suspect has been identified, which distinguishes him/her from an unknown offender.

Number of Incidents by Month

Agencies are required to report the incident date when submitting data via NIBRS. The 3 months with the highest reported number of incidents at schools were *September*, *October*, and *February*, respectively. (See Table 3.)

Offense Type

In NIBRS, the offense type is a mandatory data element. When looking at Crimes Against Persons, assault offenses were most frequently reported when school was the location. For Crimes Against Property, larceny/thefts were more commonly reported than other offenses. Drug/narcotic offenses were the Crime Against Society that was most often reported. (See Table 4.)

Weapon/Force Involved

Law enforcement agencies can indicate up to 3 types of weapons or force used by the offender. This is a conditional mandatory data element (i.e., the information is only collected for the offenses of murder and nonnegligent manslaughter, negligent manslaughter, justifiable homicide, kidnapping/abduction, sex offenses, robbery, aggravated assault, simple assault, extortion/blackmail, weapon law violations, and human trafficking).

When specific weapon types were reported, *personal weapons* was the category most reported for incidents at school locations, followed by *knife/cutting instrument*, then *handgun*. (See Table 5.)

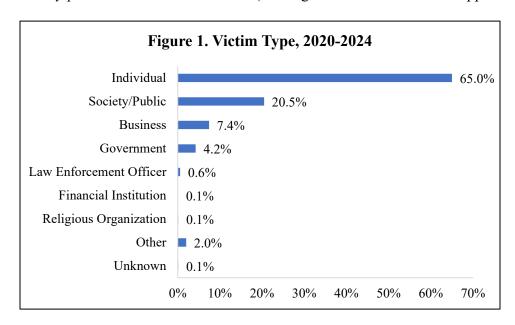

Victim Type

The type of victim is a mandatory data element in NIBRS. Law enforcement agencies categorize each victim associated with an incident and can report a maximum of 999 victims within an incident. Most (65.0%) of the 1,539,149 victims of crime at school locations from 2020 to 2024 were reported as *individuals*. Society/public followed with 20.5%. (See Figure 1 and Table 5-A in Appendix A.)

Victim Characteristics: Crimes Against Individuals and Law Enforcement Officers

Law enforcement agencies report various characteristics (e.g., age, race, sex, ethnicity, and resident status²) when the victim type is a person (i.e., individual or officer). Age, sex, and race are mandatory, while ethnicity and resident status are optional. Over the 5-year period, there were 1,009,017 victims reported as individuals or officers.

Victim Age

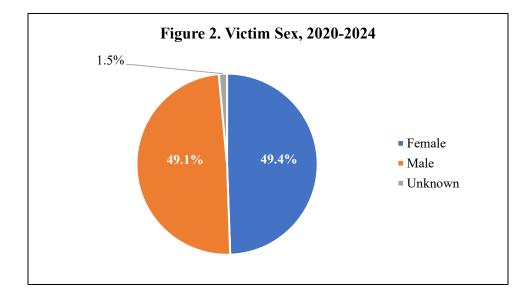
The victim age groups used in Table 6 typically define various levels of class types (i.e., elementary, middle school, high school, or college). It should be noted when the victim is an officer, the only valid ages are 17 through 98 years. The age group with the highest number of victims over the 5-year period was 19 or older. For ages 18 or under, victims were most frequently reported in the 13 to 15 age group.

Victim Sex

Females accounted for the highest percentage of victims at schools over the 5-year period. (See Figure 2 and Table 6-A in Appendix A.)



² Resident Status identifies whether individuals are residents or nonresidents of the jurisdiction in which the incident occurred.

Victim Race

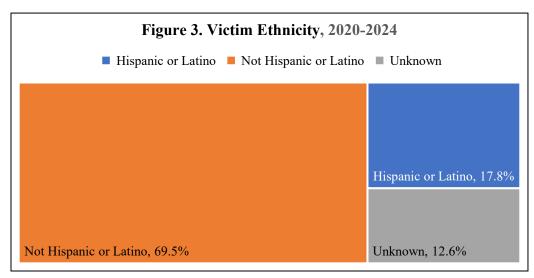
White was the most specific reported race, with 631,349 victims. Black or African American accounted for 267,783 victims, followed by Asian with 30,605. The race was reported as unknown for 67,891 victims. (See Table 7.)

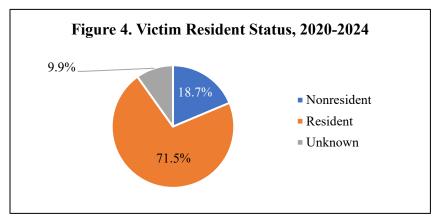
Victim Ethnicity

In NIBRS, reporting the ethnicity of the victim is optional and was submitted for 865,737 victims of crime in schools. Over the 5-year period, agencies most often reported victim ethnicities as *Not Hispanic or Latino* (69.5%). *Hispanic or Latino* accounted for 17.8% of the victims when ethnicity was reported. *Unknown* was reported for 12.6% of victims. (See Figure 3 and Table 7-A in Appendix A.)



Because of rounding, the percentages do not add to 100.0.

When the victim type is a person (i.e., *individual* or *officer*), reporting the *resident status* is optional. As mentioned earlier, *resident status* identifies whether the person resided in the jurisdiction where the incident occurred. Law enforcement agencies reported 584,307 victims were *residents*, while 152,775 were *nonresidents*. The *resident* status was reported as *unknown* for 80,631 victims. (See Figure 4 and Table 8-A in Appendix A.)

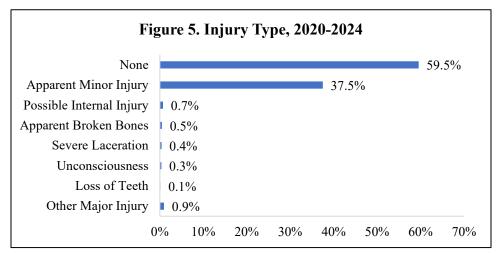

Injury Type

Law enforcement agencies are mandated to report the bodily injury type. They may report up to 5 injuries when the victim type was an *individual* or *officer* and when 1 or more of the following offenses was involved with the incident: Crimes Against Persons, ** robbery*, and ** extortion/blackmail.

Agencies most often chose the category of *None* when answering about injury type. When an injury occurred, agencies reported *apparent minor injuries* most frequently. (See Figure 5 and Table 9-A in Appendix A.)

³ The Crimes Against Persons for which the injury type is collected are Aggravated Assault, Fondling, Human Trafficking—Commercial Sex Acts, Human Trafficking—Involuntary Servitude, Kidnapping/Abduction, Rape, Sexual Assault with an Object, Simple Assault, and Sodomy.

Reporting the victim-to-offender relationship(s) is mandatory when the offense is a Crime Against Persons or Property and the offender is not *unknown*. However, when the offense is a Crime Against Property, the relationship is only reported when the victim is a person (i.e., *individual* or *officer*). When agencies identify more than 10 offenders, the relationship of the 10 most closely related to the victim should be submitted.

An important note: the count of relationships is not simply the number of victims and/or offenders. For example, if an incident has 4 victims and 2 offenders, 8 relationship pairings would be reported (i.e., 4 victims multiplied by 2 offenders equals 8 relationships). Over the 5-year period, the victim was most often reported as an *acquaintance* of the offender. (See Table 8.)

Offender Characteristics

In NIBRS, law enforcement agencies can report up to 99 offenders involved in an incident. The *age*, *sex*, and *race* of the offender(s) are mandatory data elements when those demographics are known, but reporting the *ethnicity* of the offender is optional.

Offender Age

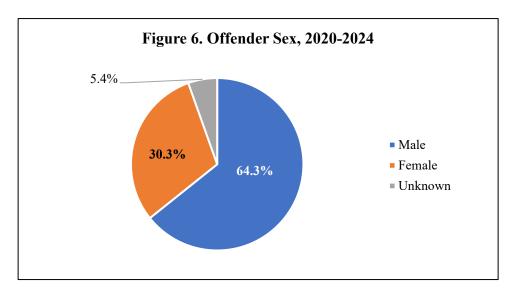
The *age* was reported for 1,250,077 offenders when *school* was the location of the incident. The age group with the highest number of offenders over the 5-year period was *13 to 15*. (See Table 9.)

Offender Sex

Law enforcement agencies reported the *sex* for 1,250,077 offenders. *Males* accounted for the highest percentage, at 64.3%. (See Figure 6 and Table 10-A in Appendix A.)



Offender Race

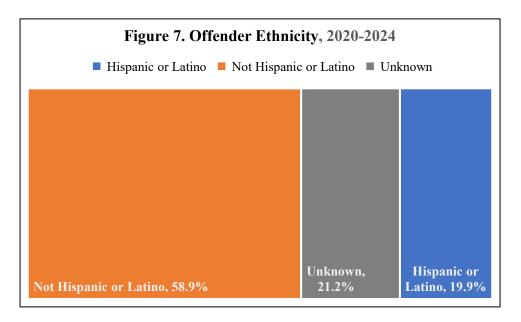
The most reported *race* of offenders was *White* (53.1%), followed by *Black or African American* (33.9%). Law enforcement agencies reported the race of offenders as *unknown* for 126,320 offenders. (See Table 10.)

Offender Ethnicity

The ethnicity of the offender was reported for 981,636 of the 1,250,077 offenders associated with crime in schools. Most offenders committing crimes in school locations over the 5-year period were reported as *Not Hispanic or Latino (58.9%)*. *Unknown* ethnicity was reported for 21.2%, and *Hispanic or Latino* was reported for 19.9%. (See Figure 7 and Table 11-A in Appendix A.)



Summary

The information presented in this report includes features associated with Crimes Against Persons, Property, and Society; however, it does not identify the factors which prompt crimes in schools. Rather, the information is intended to show the richness of NIBRS data in presenting the characteristics (e.g., victim and offender demographics, weapon type, and injury type) involved with criminal incidents that occur at schools. By examining these facets, law enforcement agencies, policymakers, and school officials can discover trends that help develop strategic plans and proactive policies to protect educational institutions of all levels.

Characteristics of NIBRS

The number of law enforcement agencies submitting data to the FBI's UCR Program regarding crime in schools via NIBRS steadily increased from 6,013 agencies in 2020 to 9,047 agencies in 2024. As the number of agencies that transitioned to reporting crime via NIBRS increased so did the population coverage—from representing 179,578,711 residents in 2020 to 279,175,031 residents in 2024. Increases in reported incidents, offenses, victims, and known offenders may not indicate a marked rise in crime at school locations but may be a result of increased agency participation in NIBRS.

Characteristics of incidents and offenses

Most incidents occurred in *September (159,111)*, which is shortly after many students return to school. *Assaults* (Crime Against Persons–652,303), *larceny/thefts* (Crime Against Property–234,601), and *drug/narcotic offenses* (Crime Against Society–244,002) were the most common crimes occurring at school locations; *personal weapons* (hands, fists, and feet–411,192) were the most frequently reported weapon type; and when there was an injury, it was most often *minor (214,008)*.

Characteristics of victims and offenders

When looking at victims aged 18 or younger, the age group with the most victims was 13 to 15 (272,284). Females (498,934) were reportedly victimized more frequently than males (495,303), and White (631,349) was the most reported race of the victim. When reported, victims' ethnicity was most often Not Hispanic or Latino (602,020). Victims were normally residents (584,307) of the jurisdiction where the incidents took place. The age group with the most offenders over the 5-year period was 13 to 15 (478,279); males (803,667) were more commonly reported as offenders than females (378,817); White (663,365) was reported most frequently as the race of the offender; the ethnicity reported most often was Not Hispanic or Latino (578,030); and the victim was usually acquainted (410,538) with the offender.

Appendix A

Incidents

When a complainant reports a crime to a law enforcement agency, the agency submits facts about the incident to the FBI's UCR Program. In NIBRS, an incident is defined as 1 or more offenses committed by the same offender, or group of offenders acting in concert, at the same time and place. NIBRS considers all offenders in an incident to have committed all the offenses, thus acting in concert. However, if 1 or more of the offenders did not act in concert, then the agency should report more than 1 incident. The concept of same time and place presumes if the same person or group of persons committed more than 1 crime and the time and space intervals separating those offenses were insignificant, all the crimes make up a single incident.

Offenses

Offenses are categorized as:

- Crimes against Persons (e.g., *murder*, *rape*, and *assault*) whose victims are people.
- Crimes against Property (e.g., *robbery*, *burglary*, and *bribery*) for which the goal is to obtain money, property, or other benefit.
- Crimes against Society (e.g., *animal cruelty*, *drug abuse violations*, and *gambling*) which represent society's prohibition of engaging in such activity.

One (1) offense is counted for each victim of a Crime Against Persons, while 1 offense is tallied for each distinct operation of a Crime Against Property and each Crime Against Society. Law enforcement agencies may report up to 10 of 71 Group A crimes occurring within a particular incident. Group A offenses are more serious in nature (e.g., *murder*, *rape*, and *human trafficking*). (See Table 1-A below.)

NIBRS also includes 10 minor crimes classified as Group B offenses (e.g., *curfew/loitering/vagrancy violations*, *disorderly conduct*, and *driving under the influence*) for which only arrests are reported to the FBI's UCR Program. (See Tables 1-A and 2-A below for a list of Group A and Group B offenses.) Group B offenses are not addressed in this report.

Details regarding only offenses known to law enforcement should be reported following an investigation after a call for service or complaint. Exogenous information (e.g., findings of a court, coroner, jury, or prosecutor) are not reported.

Data Elements and Data Values

Law enforcement agencies report data to the FBI's UCR Program via NIBRS using data elements and data values. A data element condenses meaningful information from a lengthy incident description into a short code. Details of each crime component are described with 58 established data elements from the Group A Incident Report and Group B Arrest Report. Examples of data elements are *location type*, *bias motivation*, *age of victim*, *race of offender*, type of *weapon/force involved*, and *type of injury*.

A data value is the information which can be reported for each data element. For example, under the data element *sex of the offender*, the values are *female*, *male*, or *unknown*. Submitting agencies should choose the most appropriate characteristic(s) from the assigned codes. Some data elements permit the selection of more than 1 data value. For instance, agencies can enter up to 3 values under the data element *weapon/force involved* and up to 5 *injury types* when the victim is a person.

Prior to 2010, school/college was the only data value available to agencies under the data element location type, when an incident reportedly occurred at an educational institution. School—elementary/secondary and school—college/university were added as data values in 2010 to better distinguish between the demographics of the students enrolled. School—elementary/secondary includes institutions for the instruction of children from preschool through 12th grade. School—college/university includes institutions of higher education which give instruction in specialized fields, community colleges, and trade schools. Although agencies are encouraged to report the more specific data value (i.e., elementary/secondary or college/university) when a criminal incident occurs at a school location, the original school/college option is still available for use.

Mandatory, Conditional Mandatory, and Optional Data Elements

Data elements are classified as either mandatory, conditional mandatory, or optional. Law enforcement agencies are required to report some information (i.e., mandatory data elements) to have a complete submission. Other data elements are conditional based on the data values provided for other data elements. Data values under optional data elements can be submitted at the discretion of the agency. Examples of each type are shown below.

- Mandatory: UCR offense code, *location type*, and *type of victim*
- Conditional Mandatory: age, sex, and race of the victim if the type is an individual or officer
- Optional: ethnicity of the victim and resident status of the arrestee
